Kids for Compassionate Conservation: PASA and its members across Africa conduct a pioneering international conservation education initiative. It is centered around a custom-designed children's book that teaches empathy for wildlife. Its unique five-day curriculum, which is filled with drawing, group projects, and other creative and fun activities, stands in stark contrast to standard teaching methods in Africa. The goal is to engender a long-term shift in communities' attitudes and behaviors toward conservation in order to reduce negative impacts on primates and the environment. The program has obtained excellent results in evaluations about students' understanding of their roles in protecting wildlife.

Primate Care Training Program: High quality care is crucial to the welfare of the animals rescued by PASA member wildlife centers, most of whom need specialized treatment to recover from the physical and psychological trauma they endured. PASA sends highly experienced instructors to the sanctuaries to provide customized training for all the animal care staff. This produces significant long-term improvements in the welfare of thousands of primates at the wildlife centers.

Emergency Support Program: Wildlife centers in Africa are constantly threatened by the risk of disasters, which include floods, severe storms, fires, political instability, and disease outbreaks such as the recent Ebola crisis. PASA provides emergency grants for our member organizations in Africa, and works with the organizations to resolve the issues and ensure they can continue to provide excellent care to the animals who depend on them.
